Sub: Huge scarcity of fund and liabilities of Rs 220 Cr in Karnataka reg.

Respected Sir,

It is bring to your kind notice that day by day the financial crisis getting increased, we are unable to pay in time the Electricity bills, water bills, rent for the hired land / buildings, payments for the hired vehicles, since 4 months the labour payments not done, third party payments for Bank EMI of employees, society payments, temporary advances to meet the local maintenance expenditures etc. As on today the total liabilities of Karnataka circle is Rs 220 Cr. It is very well known that there is financial crunch all over BSNL, but with available earned revenue we need to priorities the payments which are not being done.

- 1. First priority should be given to Electricity and Rents of the Land/ buildings if we don't whatever the external effort to gain the customer will be lost when the exchange / BTS are itself in Off condition.
- 2. Labour payments, if not every where lots of developmental activities are in fast progress and we need to depend on the labour force and are petty paid labours if they have not been paid since four moths what will be their family condition and how we can entrust work to them, it is very inhuman thing.
- 3. Payments for the hired vehicle, if not done how to maintain the exchange / BTS / cable breakdowns?, very difficult. To compensate for the delay payments to hired vehicles to fields one thing can be done that all the hired vehicles to administrative offices may be stopped for some time so that it can be compensated for the fields.
- 4. Third party payments if not done in time, it is against the MOU agreement and leads to unnecessary penalty to the employees and affects the CIBIL score of employees with the financial institutions. If any unforeseen happens for some employee in the absence of his / her deducted premium payment to LIC , then the claims of benefits will be under question. The policy will lapse in the nonpayment of 3 premiums which is of more risk.
- 5. Temporary Advances if not paid, it affects the day to day maintenance work and in turn affects the quality of service and ultimately loss of revenue to the BSNL.

Hence it is our humble appeal to you that kindly ensure that CO allots the funds on prime priority for the above sequential rather than any payments.
