Sub: Meeting with SNEA to consider of request transfer of SDEs/AGMs- reg.

A meeting has been held in the CGM's chamber on 20/05/2019 at 11.00 hours as requested by SNEA vide their letter dated 16/5/2019 ,for consideration of request transfers of SDEs/AGMs. The following officers of Circle Office and office bearers of SNEA attended the same.

During the meeting SNEA pressed for consideration of Incoming request transfers of SDEs/AGMs who is going to complete 2 years in May 2019 and requesting for transfer back to parent SSA. CGM explained about the present situation of vacant positions in SSA's from where the officers are likely to be transferred on completion of 2 years and embargo on Company cost transfers issued by CO ND.

Karnataka Circle is aware of the difficulties of such executives and has already taken up with BSNL Corporate Office highlighting the shortage of staffs in different SSAs and to consider Company cost transfer to fill up the vacancies after considering the incoming request of SDEs/ AGMs.

Further Circle Administration is constantly pursuing with Corporate Office for getting permission to transfer on Company cost, so that the request transfers can be considered and results are expected shortly.

BSNL is passing through a very difficult phase and hence, in spite of difficulties, the officers should contribute more and to focus on improving operational parameters, demand generation, improving revenue etc. so that embargo put up HQ is lifted quickly.

Therefore CGM requested SNEA to convey the above to their members and others that the management is actively pursuing with HQ and as soon as the orders are received from BSNL Headquarters, immediately incoming request transfer will be issued.
