Subject:- Submitting the agenda for formal meeting regd.,

The general body meeting of SNEA Belagavi held on 09-08-2017, and discussed various issues related to BSNL Services and also HR issues. Members were very much annoyed by the fact that "NONE" of the issues raised till now have been resolved and still district administration is continuing to test the patience of the members. The members unanimously decided to submit the agenda for discussion and also serve the notice for agitation to register our protest about the working of O/o the GMTD Belagavi.

Agenda:

1. **Considering request Transfers in the cadre of JTO/SDEs:** We are really tired of explaining the issue time and again, the administration is become dumb and deaf and playing with the sentiments of members who waiting for transfers. The Administration has lost its credibility by not fulfilling the promises it made time and again to both to this association and to the individuals. We once again request management at least for once keep its promise of issuing transfer orders.
2. **Abnormal delay in issuing posting orders:** We fail to understand the reason behind the delay in issuing posting orders, for LA AGM/SDE or regular posting orders to incoming executives/non-executives. This administration has already created a record in itself by delaying the AGM posting orders for more than three months in turn their salary too. And to our surprise the posting orders issued after such a delay and brain storming by administration are of laughable stuff. One SDE is posted with order as SDE Phones/Trans/Mobile/NOFN for one SDCA and other is posted as only SDE NOFN/Trans, and another SDCA is left with no SDE/JTO/TTA. The very intention / interest of such posting orders are questionable in nature. We were astonished to see that even DGM posting orders are delayed beyond any justifiable time. We request all such orders should be reviewed in the better interest of BSNL.
3. **File movement in O/o The GMTD:** This issue was deliberated at length in the last meeting and very workable solutions were suggested by The PGM himself. However not to our surprise not a single step was ever taken to implement the suggestion. And same old story of delaying the file in the name of "file missing" or "misplacing the file" is still continuing. And signing the file putting the old date has now become the standard practice. We request the suggestion for smooth file movement be implemented in true spirit.
4. **Scrapping:** When the highest authority in BSNL CO is monitoring the weekly / monthly progress of scrapping un-serviceable stores, in Belagavi in spite of many requests of Officers concerned and also from this Association, the administration has still to process the files. The cases vary from few months to few years. The case of Vehicles off road since many years is one such case where in even after many requests by Association, there is no action from administration. We request to "Swatch BSNL Belagavi" by scrapping all the un-serviceable stores at the earliest.


