**Sub: Rule 8 Transfers of JTOs from Karnataka to other circles.**

Ref: Minutes of the meeting endorsed vide Endt. No.SR/SNEA/2-20/2016-2019/KW/14 dated at Bangalore the 7TH Feb 2017 of CGMT Karnataka Circle.

At the outset, we place on record, the prompt and transparent action taken by the administration on the processing of the Rule 8 transfer cases expeditiously. However in this regard it is brought to your kind notice that, during the formal meeting held on 1<sup>st</sup> Feb 2017, your kindness was pleased to approve 74 cases Rule-8 transfer of JTO from Karnataka circle based on the WL published vide letter No. HRD-II/3-58/OG/WL/2016/13 dtd 10-1-2017. In the said list Shri Mittapalli Shankar ( HR No.200903765) was the JTO at serial number 74. According to the agreed policy the JTOs upto serial number 74 in the published list as on that date are to be considered for Rule 8 transfer.

But now, the list being revised vide letter no. HRD-II/3-58/OG/WL/2017/22 dtd 23-02-2017, by including the JTOs who were on deputation, the position of Shri Mittapalli Shankar ( HR No.200903765) has gone down to 79.

As such, the names of 5 JTOs who are presently on deputation were inserted in between as per the revised guidelines of BSNL CO, have snatched away the benefit of 5 JTOs who were to be considered as per old list ( WL 70 to 74) and now by this insertion they have been given the number in new WL as WL 75 to 79. It is most pertinent to note that the JTOs whose names have been inserted are not working in Karnataka Circle as they are on deputation. And hence, to meet the existing agreement as per the minutes, administration has to consider the Rule 8 transfer upto WL Number 79.

Further, as per the BSNL CO guidelines, the pro-rata spouse cases are also to be considered. And hence, 8 spouse cases fall in the consideration zone of Rule 8 transfers in the present process. We therefore request you to kindly take positive decision in this regard.

We therefore, request you to kindly consider 13 more Rule transfers i.e., upto revised WL No.79 and corresponding 8 spouse cases.
