Sub: Considering Rule 8 Transfers in the Cadre of JTOs.

Ref: Minutes of the **formal meetings held on 7th Feb 2017** vide Endt. No.SR/SNEA/2-20/2016-2019/KW/14 dated 7-02- 2017.
2. Further minutes of the **formal meeting held on 4th Sept 2017** vide Endt No.SR/SNEA/2-20/2016-2019/KW/105 dtd 05-09-2017.

This is in continuation to our demand for consideration of Rule 8 transfers and **to clear the complete waiting list**; which has been our consistent demand to ensure the consideration of all Rule 8 transfers. Now in all circles Rule 8 WL are cleared/being cleared.

But in so far our circle, due to very less number of JTOs were being considered for Rule 8 transfers on the ground of shortages; has since been on records, still more than 150 JTOs are waiting to get Rule 8 transfers excluding the present 55 cases in the pipeline (In all more than 212 cases pending).

One of the points raised by the administration is the uncertainty of the Direct Recruitment JTOs joining BSNL. Though very few have resigned and gone to other PSU, more than 95% have continued in BSNL and as the recruitment took place from the down side of the GATE list, the position is encouraging.

Our circle office as well as this association has taken up the issue of releasing the 3rd list of JTO recruitment and the list being already announced another 92 JTOs recruitment has begun. In our latest formal meeting on the issue held on 4th Sept 2017; the review is kept open for further consideration. The concerned para is reproduced herewith for your perusal please.

“ Further, the review of the R-8 transfer will be done depending on the number of DR JTOs reported after training in KTK Circle commensurate with R-8 transfers already considered/ to be considered”

In the background of these developments/position; the agenda of considering Rule 8 transfer be revisited and further discussion be held on this particular issue at the earliest in the light of the minutes issued on the formal meeting held with us on 4th Sept 2018.

Kindly inform us the date and time for the discussion on this issue.
