# **Sub:** Short Cut methods adopted by some SDEs in Karnataka Circle to avoid long stay transfers within Circle using external influence reg:

Ref: No: 1-7/2017-Pers II dated 03.08.2017.

This is in continuation to our email, discussion on the above issue. The General Secretary of SNEA has also taken up the said issue with Dir HR vide letter No. No: SNEA/CHQ/DIR(HR)/2015-18/79 dtd 18<sup>th</sup> August, 2017 and protested the issue. The copy of the letter is enclosed h/w for your information.

In this regard, it is further brought to your kind notice that few more SDEs have already submitted their application for transfer to these non-territorial circles like NOC, STR, STP etc., and the same are reported to be forwarded to circle office from the field units especially from BGTD. These SDEs who have given transfer applications to these non-territorial circles are in the longstay list to be considered during March/April 2018 and hence to avoid the transfer to other SSAs now they will try these shortcuts.

We SNEA, being recognised Executive Association are answerable to all those SDEs who have obeyed the transfer orders and joined various SSAs including 15 to 18 lady SDEs despite having very serious medical and family problems, education of their school going children are subjected to the said heartburn and are bitterly complaining against the discriminative actions of the administration.

We therefore request you to kindly take all suitable action to ensure that some few SDEs who have influence, etc., etc., would never be allowed to avail these shortcut transfers to permanently avoid the long stay transfers. Hence suitable instructions be issued to all field units in this regard and also all such applications on record/process be duly rejected.

In such previous attempts by some SDEs, CGMT Office had promptly brought the issues to the notice of BSNL CO and got such transfer orders cancelled. But in the instant case; without following such procedure, the officer was relieved from circle office. We request you to kindly and immediately write back to BSNLCO informing all the ground realities and policy being followed by Karnataka Circle in this regard.
