- Copy of correspondences made vide DGM(P&EF) Ltr No.AP/14-1/TA-31/Stipend/55 dated 24.05.2017 and DGM(CSC-ERP) Ltr No.ERP-CSC-Tax/EPF Corr/2017-18/21 dated 12.09.2017 with the EPFO Office based on the guidelines issued by BSNL CO under letter No.500-85/CA II/BSNL/EPF/2013/Vol VI dtd 30.03.2017 is enclosed.
- 2. EPFO RO, K R puram was consulted on 12.07.2017 in connection with implementation of the orders of higher pension under para 11(3) of the EPS,1995. It has been intimated orally that the higher pension is not yet implemented in EPFO K R Puram office due to some ambiguities. EPFO assured that the office will communicate further to this office in this regard.
- 3. Minutes of the meetings are not recorded.
- 4. Meetings are regularly conducted with EPFO authority and matter followed up.
- 5. BSNL Corporate office has ordered to implement the higher pension option in consultation with the jurisdictional EPFO office. Once the approval is accorded by EPFO for implementation of higher pension, the option can be implemented based on EPFO guidelines.
- 5. No employee has been brought under the benefit of higher pension scheme till date.
