**Sub: Considering Rule-8 Transfers in the Cadre of JTOs.**

Ref: Minutes of the meeting endorsed vide Endt. No.SR/SNEA/2-20/2016-2019/KW/14 dated at Bangalore the 7<sup>th</sup> Feb 2017 of CGMT Karnataka Circle.

The pending WL of Rule-8 transfers are huge in Karnataka circle as transfers were not considered at all on the ground of no addition of JTO either through promotion of direct recruitment. Now addition of JTOs commenced since last year by regularization and LICE.

Accordingly in the previous formal meeting held on 1<sup>st</sup> Feb 2017, it was agreed to proportionately consider the cases hence minutes were issued to consider 74 Rule-8 transfers and thereafter 71 Rule-8 transfers are considered as against 93 LICE (11+82) JTOs being additionally joined at this point in time. In the previous year also 64 Rule-8 transfers were considered when 190 TTAs were regularized as JTOs.

Now JTO induction training consisting of about 210 LICE candidates is going on at various training centres. As per the understanding reached with us by the administration during our previous meetings, though huge waiting list of Rule-8 cases were pending, the administration being rigid to consider all the pending cases, SNEA was constrained to accept the above small figures leaving behind still a big WL of more than 220 even as of now.

SNEA, being majority association, today representing 60% of paid membership is fully aware of our responsibly of our role as 90% of our members are working in the field and directly facing the customers. We are also sensitive to the hardships faced by JTOs who are away from their parents, spouse and children and are deprived of their family life and social obligations. And are therefore justified in demanding transfer to their circles/places as such these JTOs are also aware that top officers of the rank of GM/CGM get their request transfers considered within a year or two under such social justifications.

At this juncture, it is important for the administration to discuss the issue with the majority association to consider all the pending WL of Rule-8 transfers to adopt a plan in such a way that maximum LICE trainees can be accommodated to their required places without much

disturbances as well as effecting Rule-8 transfers. Hence we most earnestly request you to kindly fix the date and time within a week time to clear the anxiety of the stake holders and make them work with peacefully and effectively.

We assure you that the members of this association will do all their best to support the aspirations and targets of CGMT in the coming days and at the same time will not be complacent if our legitimate genuine Rule-8 transfer is not dealt judiciously without discrimination between JTO levels to GM/CGM level.
